

Adventure Tails Terms of Service

Please acknowledge the following terms of service by reading and signing below.

- 1) I acknowledge that Adventure Tails provides services in group environments and that Adventure Tails has the right to refuse pets that are not suitable in these environments. By signing this I am telling Adventure Tails that my pet is generally well-behaved and friendly toward other people and animals.
- 2) I recognize and acknowledge that there is inherent risk involved in allowing my pet to be outside of town and in public spaces. If my pet fails to return when called in an off-leash setting, I am responsible for my pet and its actions. Adventure Tails employees will attempt to recall and locate missing pets to the best of their ability while still providing safe and adequate care to the other animals in their charge.
- 3) I recognize that I am responsible for my pet's activities whenever and wherever those activities occur and as such Adventure Tails is not responsible for damages caused by my pet in my home, Adventure Tails vehicles, and any other public or private property my pet may visit while in the care of Adventure Tails.
- 4) I agree that Adventure Tails is not responsible should my pet become aggressive or threatening towards people or dogs. I acknowledge that Adventure Tails will make their best efforts to remove my pet safely and immediately from the situation.
- 5) I acknowledge that Adventure Tails is not responsible for any injuries or the contraction of viruses/diseases/parasites my pet may incur while in the care of Adventure Tails. Adventure Tails will attempt to contact me personally but in the event that I am not immediately available, I authorize Adventure Tails to administer first aid and seek veterinary attention should Adventure Tails make the judgment that such attention is needed or advisable. I acknowledge that Adventure Tails is not financially responsible for any fees accrued in the process of obtaining medical attention on my pet's behalf and agree to indemnify Adventure Tails from any cost that may be incurred.
- 6) I acknowledge that Adventure Tails reserves the right to remove my pet from their care permanently should Adventure Tails deem my pet's behavior dangerous or unsuited for Adventure Tails services.
- 7) I acknowledge that Adventure Tails reserves the right to refuse my pet's participation in any Adventure Tails services should my pet be coughing excessively or showing other signs of illness. Adventure Tails will notify me immediately if they are unable to provide service to my pet due to suspected illness and I will not be charged any fees.
- 8) I acknowledge that the limit of Adventures Tails liability to me for any reason is limited to the fees that I have paid to Adventure Tails for the visit that my pet had with Adventure Tails on the occasion that the liability of Adventure Tails arose. I further acknowledge and agree that I will indemnify and save harmless Adventure Tails from any liability to any third party arising from actions of my pet while in the care of Adventure Tails.

I agree to all of the terms and conditions above and this waiver shall remain in effect on all future dates that my pet will require the services of Adventure Tails.
